### Regulations

- Permit expires one (1) year from date of issue. Cost is \$0.20 per sq.ft./min.\$30.00
- Legal land survey with description of the property MUST accompany application.
- No accessory building or part thereof shall project in front of any building line.
- The maximum height shall be 6m with a minimum of 1.5m (4.9ft) from any property line and 2m from the nearest corner of a residential dwelling.
- When abutting a residential property or residential zone, accessory building shall not be located closer than 1.5m from the abutting property or zone.
- An accessory building shall have a maximum floor area of 85m<sup>2</sup>(915 Ft<sup>2</sup>). On lots with an area equal to or greater than 3035m<sup>2</sup>(32668 Ft<sup>2</sup>), and where two accessory buildings are proposed, the maximum floor area of all buildings shall not exceed 110 m<sup>2</sup> (1184 Ft<sup>2</sup>).
